OF FINAL REDISTRICTING PLAN FOR TEN COUNCIL DISTRICTS FOR THE CITY OF AUSTIN

THE INDEPENDENT CITIZENS REDISTRICTING COMMISSION

October 27, 2021

Pursuant to City of Austin Charter, Article II, Section (3)(G), Color II, 2021, the Independent Citizens Redistricting Commission unanimously adopted a final redistricting plan, attached as Exhibit A, specifically describing the district boundaries of each of the ten council districts for the City of Austin. The final redistricting plan adopted by the Independent Citizens Redistricting Commission on Color II, 2021, establishing the district boundaries of each of the ten council districts for the City of Austin, meets the criterial established in City of Austin Charter, Article II, Section (3)(E)(1-7).²

¹ See City of Austin Charter, Article II, Section (1)(C) ("The independent citizens redistricting commission...shall be empowered to divide the city into ten (10) geographical council districts for the election of council members. The commission shall designate each council district by a number or other designation."); City of Austin Charter, Article II, Section (3)(B) ("In 2013 and thereafter...the Commission shall adjust the boundary lines of the ten (10) single-member districts in conformance with the standards and process set forth in this Article.").

² "The Commission shall establish the boundaries of the council districts for the City of Austin in a plan using the following criteria as set forth in the following order of priority: (1) districts shall comply with the United States Constitution. Each council district shall have reasonably equal population with other districts, except where deviation is required to comply with the federal Voting Rights Act or allowable by law; (2) districts shall comply with the federal Voting Rights Act (42 U.S.C. Sec. 1971 and following) and any other requirement of federal or state law; (3) districts shall be geographically contiguous; (4) the geographic integrity of any local neighborhood or local community of interest shall be respected in a manner that minimizes their division to the extent possible without violating the requirements of any of the preceding subsections. A community of interest is a contiguous population that shares common social and economic interests that should be included within a single district for purposes of its effective and fair representation. Communities of interest shall not include relationships with political parties, incumbents, or political candidates; (5) to the extent practicable, district boundaries shall be drawn to encourage geographical compactness such that nearby areas of population are not bypassed for more distant populations; (6) to the extent practicable, district boundaries shall be drawn using the boundaries of existing election precincts; and (7) to the extent practicable, district boundaries shall be drawn using geographically identifiable boundaries."
